RESPONSIBILITIES:

a. Walk and/or care for your pet on the dates agreed upon. Shall perform the agreed-on services in an attentive, reliable and caring manner and the Owner undertakes to provide all necessary information to assist in this performance.

b. The walker shall notify the owner of any occurrence pertaining to the dog which may be relevant to care and well-being of dog(s).

c. The walker shall supply and be equipped with scooper and waste bags and will duly remove the dog's feces from all public spaces.

d. The Owner will provide suitable harnesses, collars and leads as approved by the Walker as well as coats or muzzles if required.

e. The Walker shall not be obliged to perform any other duties except those specified on the Owner's Information sheet and Pet Information sheet

PAYMENT FOR SERVICES:

SECURITY: The walker warrants to keep safe and confidential of all keys, remote control entry, devices, access codes and personal information of the Owner and return same to Owner at end of the contract period or immediately upon demand.

LIABILITY:

- a. The Walker accepts no liability for any breach of security or loss of or damage to Owner's property if any other person has access to the property during the term of this contract.
- b. The Walker shall not be liable for any mishap of any nature which may be fault of a dog or cause by a dog who has been unsupervised access to the outdoors
- d. The Walker is release of all liability of injury to dog(s) cause by other dog(s) or animals not under control of Walker

INJURIES:

Generally, the Owner shall be liable for all medical expenses and damages resulting from an injury to Walker caused by the dogs as well as damage to the Owner's property. However, Denise Sosa of Your Dog Walker waives any right to recovery from Owner for any injuries that Denise Sosa of Your Dog Walker may sustain while performing services under this agreement and that are results of negligence of Denise Sosa of Your Dog Walker.
